

Audland, Christopher

07/07/1926 Wiesbaden [Germany] Parallel names: Audland, Sir Christopher J.

Christopher Audland on leaving Winchester College joined the British Army (1944-1948), thus following his father's footsteps, serving in both the Middle East and Greece. However, his ambition was to join the Diplomatic Service, a career which he entered in 1948. His initial posting was in the Commonwealth Liaison Department. In September 1949 he was seconded to the staff of the Political Division of the then Control Commission for Germany (British Element) (CCG (BE)) at Berlin. The CCG (BE) soon moved to Bonn, where he was Britain's chief negotiator of one of the Bonn Conventions, which in 1954 were to give independence to West Germany. In 1952, he was appointed Deputy Head of the UK Representation to the Council of Europe, a post in which he became personally familiar with most of the Founding Fathers of the European Economic Community (EEC). .In 1955, he was appointed Second Secretary in the British Embassy in Washington, a position he held until 1958. He returned to Britain to the Department of Foreign Affairs in London and from 1961 - 1963 he was a key member of Edward Heath's team, whose efforts to negotiate rapid British entry to the EEC were frustrated by Charles De Gaulle's veto. The ensuing years were spent on various diplomatic assignments in Argentina and the Commonwealth Office. From 1968 to 1970 he gained experience of running a government department when he became head of the Science and Technology Department at the Foreign Office. In 1970 he was appointed Deputy to the Head of the British Delegation which negotiated the Quadripartite Agreement on Berlin (1971)...When Britain finally entered the EEC in 1973, he became a top-ranking Official of the European Commission for thirteen years. From 1973 to 1981 he was Deputy Secretary-General of the European Commission. From 1981 to 1986, he was Director-General of the European Commission Directorate-General for Energy (DG XVII). After the Chernobyl disaster on 26 April 1986, he was additionally charged by the Commission with the task of co-ordination of the work of all the Commission's Directorates-General involved in proposing and executing the EEC's response to the disaster..Christopher Audland retired from the Commission in 1986, was knighted in 1987, and has since pursued other challenges.

Director General for Energy of the Commission

Documents from 1984 to 1986

Christopher Audland was Director-General for Energy of the European Commission from 1981 - 1986, it was usually known in those days as DG XVII and was both complex and large being composed of six different Directorates dealing with energy policy as a whole, solid fuels, hydrocarbons, nuclear energy and negotiations with other countries, energy saving and the Euratom safeguards. For the first four years he had Steve Davignon as Commissioner, who was replaced by Nic Mosar the Commissioner from Luxembourg in 1985 with the incoming Delors Commission.

Solid fuels gave Audland much work in particular with the projects for liquefaction and gasification of coal and state aids for coal. A principal action of the Community as regards hydrocarbons was the hydrocarbon technolgy projects scheme. Another important objective was to build bridges with Middle East oil producers, with involved building relations with Ali Attiga, Secretary-General of the Orgaisation of Arab Oil Producing Countries (OAPEC) and with initiating informal talks with the GCC, the Gulf Co-operation Council and finally with Fadhil Al Chalabi, Director-General of OPEC.

There was also much to do in the nuclear sector. The framework was very different from that of the EEC as they were operating under the rules of the Euratom Treaty. When the Non-Proliferation Treaty (NPT) was concluded, it was agreed that the safeguards to be applied by the newly established IAEA, within the Community, should be the subject of an agreement between the latter organisation and Euratom. This then provided for verification by IAEA inspectors of Euratom Safeguards. The Euratom Safeguards were headed by Willem Gmelin and this Directorate was based in Luxembourg which meant that Audland had to spend a certain amount of time every month in Luxembourg. A review was also carried out during this time of the Euratom Treaty. Since other Directorates were involved an Inter-Service Group (ISG) under Audland's Chairmanship was established which made recommendations to the Commission.

Another sector of nuclear activity which produced a lot of work was that of Nuclear Supply agreements, the principal ones were with Canada, the US and Australia.

Last but not least of his duties lay in furthering the Commission's relations with the IAEA (Vienna Agency) and its Director General Hans Blix and the easing of safeguards problems with the agency caused by duplication of operations.

Most importantly during Audland's period in the Energy Directorate he handled the entire consequences of the Chernobyl accident. The RBMK reactor was of Soviet design and Western experts had always had their doubts about it.

From the moment of the explosion, the nuclear staff of his Directorate-General set to work, first to gather facts and analyse them, next to keep in touch with the permanent representatives in Brussels and to develop some guidelines for a Community reaction. Unfortunately, as Chernobyl showed very little work had been done at international, Community or national levels, on how to cope with a nuclear accident of such magnitude. The habit of secrecy spilled over from military to the civil side. For the Commission the Euratom Treaty was a starting point, however the broadest forum was the IAEA or the Vienna Agency and other international organisations such as the WHO, FAO and the NEA, which played lesser roles.



Chernobyl Disaster

Documents from 1986 to 1986

Material collected by Christopher Audland in his role as Commission co-ordinator in response to the Chernobyl disaster of 26 April 1986 and its aftermath. Among these files is what Audland called his "War Diary" written in the heat of the events during the first three months following the explosion, revised early in August 1986 and which were never touched again. The implications of Chernobyl were to dominate his final months in the Commission. His initial problem lay in getting accurate information about the accident as the Soviet Authorities were very slow in giving information of value and secondly, since the first oil crisis in 1973, industrialised countries had invested heavily in alternative power, particularly in nuclear energy. By 1986 over 30% of the EC's electicity was obtained from nuclear power and with the events in Chernobyl, public doubts about safety were increasing, fuelled by the reservations of three member states, Denmark, Greece and Ireland.

Audland worked hand in hand with Hans Blix of the IAEA in gleaning information about the actual situation as it evolved. For the Commission, the Euratom Treaty was a starting point along with the FAO, the WHO the NEA (nuclear energy agency of the OECD) and the IAEA, it was realised that greater co-operation was required about safety standards for reactors. The basis for the declaration of the Tokyo Summit by the Heads of State or Government of the seven major industrial nations and the Representatives of the EC were two documents published by the Vienna Agency (IAEA) and the Commission pamphlet of "Nuclear Safety in the EC" of 1985. It was by pure fortune that the Summit in Tokyo had been fixed to take place just nine days after the Chernobyl accident. The declaration offered assistance to the Soviet authorities, urged them to provide urgenty information on the nuclear emergency, stated their satisfaction with the Soviet Union's willingness to undertake discussions with the IAEA and their support for the work of the IAEA in seeking to improve international cooperation on the safety of nuclear installations, the handling of nuclear accidents and their consequences, and the provision of mututal emergency assistance.

On his return from Tokyo, the Commission had already made proposals on the levels of radio-activity to be permitted in different foodstuffs entering the Community and a communiqué was issued from Moscow giving more information and promising greater transparency and active collaboration with the Agency in the handling of accidents. The Commission began work on the production of a Framework Communication to the European Parliament and the Council and a plenary debate was held in the Parliament on 15 May to discuss the crisis. In the following week, the Governing board of the Vianna Agency held a special post-Chernobyl session detailling the IAEA's subsequent work and on 10 June the Framework Communication was finalised by the Commission.

Audland's last act as Director-General for Energy was to attend a meeting of the IEA Governing Board in September in Paris, from where he left for Vienna in his new role as Special Adviser to the Commission on nuclear matters, to represent the Commission at the Annual Conference of the Agency, where he stressed the improvement in Euratom/IAEA co-operation and the problems of nuclear safeguards and the merits of safeguards inspectors.
